ASSUMPTION OF RISK, WAIVER OF LIABILITY and
PARENT/GUARDIAN PERMISSION FORM

CAMPER'S FULL NAME: _____

In order to participate in a Bearden Production Company (BP) Summer Arts Camp, the Parent/ Guardian of each participant must submit completed versions of this Assumption of Risk, Wavier of Liability and Parental Permission Form and the accompanying Health and Transportation Form. Participants who have not completed both forms will not be permitted to participate in camp activities until they are received.

AGREEMENT TO PARTICIPATE

To ensure that you the parents/ guardians of the camper understand and accept the risks of participation in the Bearden Production Company Summer Arts Camp, you must indicate your understanding and agreement by signing on the appropriate lines below.

CAMPER AGREEMENT

I affirm that my child's participation in the Summer Arts Camp is entirely voluntary, and understand that participation in the Summer Arts Camp may involve a risk of injury due to certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries, such as, but not limited to, the following: contact with other individuals playing in games, cooking in the kitchen class room and taking various field trips; contact with the floor, walls, posts or cooking equipment which are part of the class room/ playing area and ; any strenuous exertions, quick movements, and changes of speed/ motion, that may place stress on the cardiovascular, muscular, and skeletal systems. (1) Minor injuries such as scratches, bruises, burns and sprains, to (2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions, to (3) catastrophic injuries including paralysis and death. I understand that if I have questions about possible hazards, it is my responsibility to seek additional information from the summer arts camp staff prior to signing this form. I also understand that, despite safety precautions, Bearden Production Company (*aka Bearden Productions Center for the Arts*) cannot guarantee that my child will not be injured. I the parent/ guardian agree to assume these risks.

I understand that the best way to make sure that my child remains safe and avoid injury is to follow the rules, regulations and instructions of the staff of the BP Summer Arts Camp. I agree that my child will learn and obey all the rules and regulations and will follow all instructions of the staff of the BP Summer Arts Camp.

PARENT/GUARDIAN AGREEMENT

I agree to allow my child/ward to participate in the Bearden Production Company Summer Arts Camp and affirm that my child's participation is completely voluntary. I understand that there are risks inherent in the activities my child will engage in at the BP Summer Arts Camp (some of which are described above) which may cause serious injury or even death. I also understand that, despite safety precautions, Bearden Production Company cannot guarantee that my child/ward will not be injured. My child and I are willing to assume these risks. To minimize the risk, I have instructed my child to obey all the rules, regulations and instructions of the summer arts camp.

ASSUMPTION OF RISK, WAIVER OF LIABILITY, RELEASE & AGREEMENT NOT TO SUE: In consideration for permitting me/my child/ward to participate in the summer art camp, **I voluntarily agree**, for myself, my heirs, executors, and administrators, to the following:

TO ASSUME FULL RESPONSIBILITY FOR ANY RISKS OR LOSS, OR PERSONAL INJURY, INCLUDING DEATH that may be sustained by me/my child/ward, or any loss or damage to property owned by me/my child/ward, as a result of training for, participating in, or traveling to or from the summer camp.

1. **TO RELEASE, WAIVE, HOLD HARMLESS, DISCHARGE, & AGREE NOT TO SUE** the person or entity responsible for administering the summer camp, Bearden Production Company (*aka., Bearden Productions Center for the Arts*), or its trustees, officers, employees, agents, students, and staff (hereinafter referred to as “releasees”) from any and all liability, claims, actions, demands, expenses, attorneys fees, breach of contract actions, breach of statutory duty, or other duty of care, warranty, strict liability actions, and causes of action whatsoever, that I might now have or may acquire in the future, arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while training for, traveling to or from, or participating in the summer camp.

MEDICAL EVALUATION: I understand that I must complete and submit a completed Health and Transportation Form. I understand that it is suggested that I (but are not required to) obtain health insurance coverage for my child prior to participating in the summer arts camp. I further understand that I will be responsible for all my child's medical expenses incurred while in the care of the Bearden Production Company Staff.

PHOTO RELEASE: I give permission for photographs taken of me/my child/ward while participating in the summer art camp to be used in marketing/public relations material in the promotion of Bearden Productions Center for the Arts.
